Advancing psychosocial treatment for schizophrenia

Intermediate

This presentation will review the history and discuss the future of psychosocial treatment and psychotherapy for schizophrenia. A presentation of the longstanding contributions of Professor Gerard E. Hogarty, MSW to developing effective psychosocial treatments for schizophrenia will be given, followed by a review of recent advances and new discoveries in related populations that underscore how fundamental psychosocial treatments are to supporting recovery from schizophrenia and many other mental health conditions. The integration of pharmacological and psychosocial treatments, which is essential in schizophrenia, will be discussed.
